We hereby represent and warrant that:

- a. the financing covers a genuine underlying transaction for the sale/purchase of goods which are the subject of this Application (the "Goods", which expression shall, as the context requires, include the relevant document of title) and we confirm the accuracy of the information contained in all documents submitted;

- b. we have not obtained and will not obtain any other source of financing from any party other than you for this transaction concerned, including financing pursuant to a lease, hire purchase or factoring agreement.
- c. unless we have been permitted by your bank to present for financing of our transactions involving our related companies, the Buyers /Sellers pertaining to this transaction are not related companies; and
- d. Until all amounts owed by us to you have been fully paid, you retain all rights on the Goods and/or proceeds of sale of Goods.
- e. In the event of any proceedings or suits commenced against us arising out of or in connection with these Terms and Conditions, we agree to submit to the non-exclusive jurisdiction of the Courts in Singapore, at your option, in respect of any disputes arising out of or in connection with these Terms and Conditions. Without prejudice to the foregoing, we undertake not to commence proceedings or suits against you in the courts of any other jurisdiction. In the event of any proceedings or suits commenced by us against you, we agree that the Singapore Courts shall have exclusive jurisdiction in respect of any disputes arising out of or in connection with these Terms and Conditions.

We further undertake that:

- a. We will at your request provide other documents evidencing the transaction.
- b. We will repay you the full amount of loan and financing extended to us on due date as well as all outstanding principal, interest, charges and commissions due to you.

We agree to fully indemnify and hold harmless HL Bank from and against any and all costs, claims, demands, losses, charges and expenses howsoever and of whatsoever nature which HL Bank may sustain, incur or be liable for in connection with, or arising out of this Application and HL Bank's grant of the invoice financing.

A person who is not a party to the terms herein has no right under the contracts (Rights of Third Parties Act cap 53B) to enforce any of the terms and conditions herein.
